4. First aid measures

Eye contact

6. Accidental release measures

Procedures for cleaning up spills or leaks

7. Handling and storage

Precautions for safe handling

Observe label precautions. Keep away from heat, sparks, flame, static discharge and other sources of ignition. VAPORS MAY CAUSE FLASH FIRE. Close container after each use. Ground containers when pouring. Do not transfer contents to bottles or unlabeled containers. Wash thoroughly after handling and before eating or smoking. Do not store above 49 °C (120 °F). Storage
