#### 2. Hazards identification

#### 4. First aid measures

#### 7. Handling and storage

#### **Handling**

Materials such as cleaning rags, paper wipes and protective clothing, which are contaminated with the product may spontaneously self-ignite. To avoid the risks of fires, all contaminated materials should be placed in a metal container filled with water and sealed.
