### 4. First-aid measures

## 6. Accidental release measures

Do not handle or store near an open flame, heat or other sources of ignition. This material can accumulate static charge which may cause spark and become an ignition source. 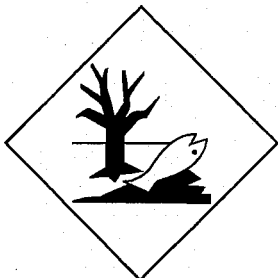
